Minutes of the previous meeting were read. A motion was made by Deb Halpenny and seconded by Dan Maloney to accept the minutes as read. All voted yes. Carried.

Assessor Holley Smalt reviewed her report.

Code Enforcement Officer Chuck Cagle submitted his report to the Town Board.

Highway Superintendent Kevin Robinson reviewed his report.

A motion was made by Dan Maloney and seconded by Bill Smith to approve the purchase of a new 2020 Chevrolet one ton cab and chassis with a 9' dump body from Wentworth Motors, Inc. for a price of \$46,249.40 minus the trade in allowance of \$30,000.00 for the 2015 Ford cab and chassis with the 9' dump body for a total amount of \$16,249.40. All voted yes. Carried.

General bills were audited and approved for a total amount of \$6,382.92. Highway bills were audited and approved for a total amount of \$32,667.28. Street lighting were audited and approved for a total amount of \$125.66.

A motion was made by Glenn Kreiley and seconded by Dan Maloney authorizing the purchase a 2021 International Navistar HX520 SFA 6x4 truck with Viking plow equipment for a total amount of

\$185,705.81. The complete package to be purchased off the Onondaga County contract #8996 and paid for out of the 2021 budget. All voted yes. Carried.

A motion was made by Deb Halpenny and seconded by Bill Smith to adjourn the meeting. All voted yes. Carried.
