General bills were audited and approved for a total amount of \$5,605.10. Highway bills were audited and approved for a total amount of \$45,360.41. Street light bills were audited and approved for a total amount of \$187.30.

A motion was made by Bill Smith and seconded by Mary Ellyn Calabrese to adjourn the meeting. All voted yes. Carried.
